- For safety reasons, *no vehicles are permitted to leave the Convention Center during open hours*; vehicles are only permitted to leave once they have sold and after we are closed to the public.
- All vehicles *must* be driven into the car corral.
- All vehicles *must* be removed from the Convention Center by Sunday, September 24, no later than 3pm or it will be towed at the owner's expense.
- All transactions are between the buyer and seller.
- Each vehicle entered in the Car Corral *must* have a Fire Extinguisher.
Vehicles are not permitted to return to the Car Corral once they are removed from the Exhibit Hall.
- Returned checks will be charged \$35.00.
- Wildwood Motor Events LLC or the Wildwood Convention Center are not responsible for damaged or stolen vehicles or any part thereof.
